

# Changing the background picture

The customizing of "Splash Screen" is added. The operation is the same as "Navigation Background" or "AV Background". Please refer to the Operation Manual of the navigation system to operate.

### Splash Screen:

The screen that appears when the Navigation system starts up.

If an image other than the one shown above is previously set (such as an image from the dealer or other source) and you change the splash screen once, you must use the CD-R (-RW) where the image is recorded to restore the previous splash screen.

## Dialled with the pronunciation of the entry in Phone Book
